This Privacy Policy explains how we collect, use, disclose, and protect your personal information in accordance with the **General Data Protection Regulation (GDPR)** and other applicable data protection laws.

1. Who We Are

Technical Data	IP address, browser type, device ID, operating system
Usage Data	Logins, activity on dashboard, email interactions
Mission Engagement	Subscription preferences, workplace mission activity, one-off
Data	donations

Communications	Feedback, inquiries, prayer requests, support requests

We do **not** collect or process **sensitive personal data** unless explicitly provided by you for mission engagement or prayer support.

3. How We Use Your Data

We use your data to:

- Process your monthly or one-time donations securely
- Maintain your Force Member account
- Send you essential notifications and reports (e.g., fund performance, Taking Territories report)
- Personalize your experience within the TMDF platform
- Respond to inquiries and provide support
- Fulfill our legal and regulatory obligations
- Improve our services and communication strategies

Legal Basis for Processing:

- Consent (Art. 6.1(a) GDPR) when you sign up or opt into communications
- Contractual necessity (Art. 6.1(b)) to provide you services you requested
- **Legal obligation** (Art. 6.1(c)) for tax reporting or compliance
- **Legitimate interest** (Art. 6.1(f)) to improve TMDF services, prevent fraud, or defend our mission

4. Sharing Your Data

We do not sell your personal data.

We may share your data with:

• **Service providers**: Payment processors, email delivery services, and hosting platforms under strict data processing agreements

- Legal authorities: When required by law or to defend TMDF's rights
- Mission affiliates: Limited non-personal data for impact reporting and strategic collaboration

All third-party processors are GDPR-compliant and only process your data on our documented instructions.

5. International Data Transfers

TMDF operates globally. Where we transfer your personal data outside the European Economic Area (EEA), we ensure such transfers are compliant through:

- The use of Standard Contractual Clauses (SCCs)
- Transfers to countries deemed to provide adequate protection by the EU Commission
- Additional safeguards such as data encryption and pseudonymization

6. Data Retention

We retain your personal data only as long as necessary for:

- The purpose it was collected
- Compliance with legal, tax, or accounting obligations
- Our legitimate mission reporting and engagement

After this period, data is securely deleted or anonymized.

7. Your Rights Under GDPR

As a data subject, you have the following rights:

- Right to access Know what data we hold about you
- **Right to rectification** Correct incomplete or inaccurate data
- Right to erasure Request deletion of your personal data
- Right to restrict processing Limit how we use your data
- Right to data portability Request transfer of your data to you or another service

- Right to object To processing based on legitimate interests
- Right to withdraw consent At any time, for communications or specific data uses
- Right to lodge a complaint With your local data protection authority

8. Data Security

We apply military-grade discipline to your data security:

- SSL encryption for data in transit
- AES-256 encryption for sensitive stored data
- Role-based access control within our systems
- Continuous monitoring and auditing for breach detection
- Periodic data protection impact assessments

Despite our best efforts, no system is impenetrable. We commit to notifying you and regulators of any significant breach within 72 hours as required by law.

9. Children's Privacy

TMDF is not intended for children under the age of 16. We do not knowingly collect data from minors without parental consent. If you believe a child has provided us data, please contact us for immediate action.
