

# Terms and Conditions

## 1. Introduction

These Terms and Conditions ("Terms") govern your access to and use of The Million Dollar Force (TMDF) platform and associated services. By registering for, accessing, or using TMDF, you acknowledge that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, you may not access or use the platform.

## 2. About TMDF

TMDF is a Christian faith-based, digitally-enabled platform operated by Network of Professionals for Missions, International, that mobilizes a global community of professionals committed to:

- Contributing \$1 monthly to gospel missions.
- Serving as workplace missionaries.

The platform integrates giving tools, reporting dashboards, and community-building features to equip members for spiritual impact.

## 3. Eligibility

Use of the TMDF platform is restricted to individuals who are:

- At least 16 years of age or the age of majority in their jurisdiction.
- Legally capable of entering into binding agreements.
- Not barred from using the platform under any applicable laws.

## 4. Account Creation and Responsibilities

To access certain services, you must register and maintain an account. You agree to:

- Provide accurate, current, and complete information during registration.
- Maintain the security and confidentiality of your login credentials.
- Notify TMDF immediately of any unauthorized access or breach of your account.

You are solely responsible for all activities under your account.

## 5. Donations and Subscriptions

When you commit to the \$1 monthly contribution, you:

- Authorize TMDF to charge your selected payment method on a recurring basis.
- May cancel your monthly subscription at any time via your dashboard.
- Acknowledge that all donations are non-refundable unless otherwise required by law.

TMDF also accepts one-time donations. All transactions are securely processed via third-party gateways.

## **6. Mission Engagement and Conduct**

As a Force Member, you agree to:

- Use the platform for its intended spiritual and charitable purposes.
- Refrain from submitting or sharing unlawful, offensive, or deceptive content.
- Treat fellow Force Members with respect and uphold the values of integrity, faith, and accountability.

TMDF reserves the right to suspend or terminate accounts that engage in conduct contrary to its values or disruptive to the community.

## **7. Communications**

By creating an account, you consent to receive essential communications from TMDF, including:

- Donation confirmations
- Fund impact reports
- Operational notices and community updates

You may also opt-in to receive promotional and inspirational content. Communication preferences can be managed in your account settings.

## **8. Privacy and Data Protection**

TMDF respects your privacy and complies with all applicable data protection laws, including the General Data Protection Regulation (GDPR). Our Privacy Policy explains how we collect, process, and protect your personal data. By using the platform, you consent to our data practices.

## **9. Intellectual Property**

All content, trademarks, logos, and materials on the TMDF platform are the property of TMDF or its licensors. You may not copy, distribute, modify, or use any content without our express written permission. Unauthorized use may violate copyright, trademark, and other laws.

## **10. System Availability and Downtime**

TMDF strives to maintain uninterrupted access to its platform. However, we do not guarantee continuous, error-free service. Planned maintenance, updates, or unforeseen issues may cause temporary disruptions. TMDF will not be liable for any losses resulting from such downtime.

## **11. Limitation of Liability**

To the fullest extent permitted by law, TMDF shall not be liable for any indirect, incidental, special, punitive, or consequential damages, including but not limited to:

- Lost donations or data
- Service interruption
- Unauthorized access

Our liability to you shall not exceed the total amount of your contributions in the past 12 months.

You agree to indemnify and hold harmless TMDF, its officers, directors, affiliates, and employees from any claims, damages, losses, liabilities, and expenses (including legal fees) arising out of your violation of these Terms or misuse of the platform.

#### **13. Suspension and Termination**

TMDF may suspend or terminate your access at any time if you breach these Terms or engage in conduct that threatens the security, values, or community of TMDF. Upon termination, all rights granted to you will cease immediately.

#### **14. Changes to Terms**

We may revise these Terms from time to time. Changes will be effective upon posting. Your continued use of the platform after changes have been posted constitutes acceptance.

#### **15. Governing Law and Jurisdiction**

These Terms are governed by the laws of Nigeria. Disputes shall be resolved exclusively in the courts of Nigeria, unless otherwise required by law.

#### **16. Entire Agreement**

These Terms constitute the entire agreement between you and TMDF concerning the platform and supersede all prior communications and understandings.
